

India set to become third-largest economy by 2030 by S&P Global Ratings



India will remain the fastest-growing major economy for at least the next three years, setting it on course to become the world's third-largest economy by 2030, as per S&P Global Ratings report. S&P expects India, currently the world's fifth-largest economy, to grow at 6.4% this fiscal and estimates growth will pick up to 7% by fiscal 2027. In contrast, it expects China's growth to slow to 4.6% by 2026 from an estimated 5.4% this year.

A JV between India and the US will launch most expensive satellite, the Nasa-Isro Synthetic Aperture Radar (NISAR), worth nearly US\$ 1 billion in first quarter of next year.

Trade strategy to achieve exports target of US\$ 2 trillion by 2030

Sixty-six Indian Airports are operating on 100% Green Energy



India is set to begin ambitious defence projects valued at Rs. 1.4 trillion (US\$ 17 billion)

Manmade fibre textiles exports to rise 75% by 2030: Textile Industry

The industry anticipates India's exports of man-made fibre (MMF) textiles to climb 75% to US\$ 11.4 billion in 2030, from roughly US\$ 6.5 billion in 2021-22, due to the Production Linked Incentive (PLI) scheme and free trade agreements with the UAE and Australia.



Incredible India: UNESCO World Heritage Sites

India is home to several UNESCO World Heritage Sites; ranging from natural wonders to architectural marvels. While some are keepers of the magnificence of history, others are a safe and lush haven for biodiversity to flourish. There are a 42 UNESCO World Heritage Sites in India, making it the sixth largest country with the majority of Heritage Sites in the world. Out of these 42 World Heritage Sites in India, 34 are cultural, 7 are natural sites, while one of them is Mixed World Heritage Site - Khangchendzonga National Park. Popular sites such as the Ajanta & Ellora Caves, Agra Fort, Taj Mahal, the Sun Temple in Konark and the Chhatrapati Shivaji Terminus (CST) are some of the earliest inscribed UNESCO World Heritage Sites in India.
